Announcement on the payment of the interest coupon no. 1 related to the convertible bonds issued by VRANCART S.A.

Vrancart S.A. hereby announces that the payment of the interest coupon no. 1 related to the convertible bonds VNC24 will be made on April 25<sup>th</sup>, 2017, in accordance with the provisions of the Issuance prospectus approved through the Decision of the Financial Supervisory Authority no. 156/February 1<sup>st</sup>, 2017.

The payment of interest will be made by means of Depozitarul Central and BRD – Groupe Societe Generale – as the payment agent – to the bond holders registered in the Bond Holders' Registry kept by Depozitarul Central as at the reference date, April 18<sup>th</sup>, 2017.

The interest will be calculated in accordance with the provisions of paragraph 2.7 "The nominal interest rate and provisions on the interests to be paid" of the Issuance Prospectus. The payment of the interest related to the issued bonds will be made by bank transfer to the account of the participants to the

RoClear system, to the accounts communicated by the bond holders through the Subscription form or to the accounts notified to the Payment Agent by the bond holders.

Details related to the calculation of interest:
