During the meeting of the Board of Administrators held on June 16th, 2016, an agreement for electricity supply was concluded with Industrial Energy S.A. Bucharest. As a part of the company's administrators are in a conflict of interests in relation to this transaction, they refrained from voting, and in accordance with the provisions of Art. 225 of Law no. 297/2004, we would like to notify the conclusion of the electricity supply agreement with Industrial Energy S.A. Bucharest, as follows:
